



Global Hockey Select League 2011-2012 Mite Contract and Payment Policy

Receipt by Global Hockey Select League of your signed contract and deposit will commit you to the full tuition. All deposits are **non-refundable**, and each player accepting a team spot is responsible for full tuition upon acceptance to the program.

The Global Hockey Select League tuition for the upcoming 2011-2012 season is \$1449.00, and two options for payment are offered. Payment may be made by cash, check, or credit card. If credit card payment is selected for either option, there is an additional \$40 processing fee and the credit card information must be supplied below.

Option 1: Discount for making a single payment for the full tuition

Players who pay the \$1449.00 tuition in full on or before April 1st are entitled to a \$40.00 discount.
